AFFIDAVIT





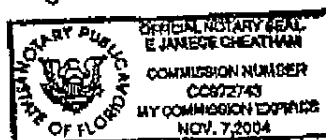
