ARTICLES OF INCORPORATION
OF

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE 1. - NAME

The name of this corporation is BURKART GRAPHIC SERVICES, INC. and their principal address is 2565 Rio Palermo, Punta Gorda, FL 33950.

ARTICLE 2. - DURATION OF CORPORATE EXISTENCE

This corporation shall exist perpetually.

ARTICLE 3. - PURPOSES

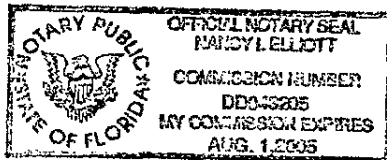
