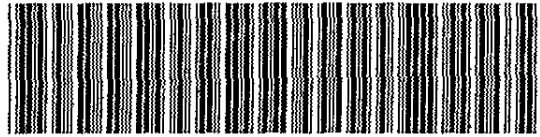

ARTICLE I




