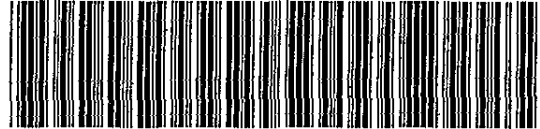



The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

FLOYD G. GAINNEY BACKHOE SERVICE, INC..

The address of the principal office of this corporation shall be 7711 N.W. 156th Avenue, Alachua, Florida 32615. The mailing address of this corporation shall be Post Office Box 1357, Alachua, Florida 32616-1357.

ARTICLE II

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, or the State of Florida or any other state, country, territory or nation.

ARTICLE III
