The undersigned, for the purpose of forming a corporation under the laws of the state of Florida, do hereby adopt the following articles of incorporation:

**Article I Name**

The name of the corporation will be:

Musser Enterprises, Inc.

**Article II Principal Office**

**Article III Purpose**

The purpose for which the corporation is organized is:

To install windows and to provide related general construction activities, and to engage in any other activity or business permitted under the laws of the United States of America and this State.

**Article IV Shares**

The number of shares of stock is:

The aggregate number of shares that the Corporation shall have the authority to issue is One Thousand (1,000) shares of Capital Stock with a par value of One Dollar and 00/100 (\$1.00) per share.

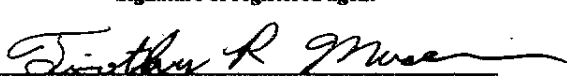
