

# ARTICLES OF INCORPORATION OF



### ARTICLE I. NAME

The name of this corporation shall be BAY BREEZE HEAT & AIR INC.

## ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the State of <u>FLORIDA</u>. This corporation's duration shall be perpetual.

#### ARTICLE III. PURPOSE

This corporation is being organized for the purpose of furnishing heating and cooling equipment and/or service to both residential and businesses and transaction of any and all business activities permitted under the laws of the State of <u>FLORIDA</u> and the United States Of America.

# ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash by this corporation of any shares of new capital stock of the same kind, class, or series, as that which the shareholder already holds, shall have the preemptive right to purchase a pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which such shares are offered to others.

# ARTICLE VI. TRANSFER RESTRICTIONS
