IG and DG Corporation.

The undersigned subscribers to these Articles of Incorporation, each a natural person, domestic or foreign corporation, partnership, limited partnership or association, competent to contract, hereby associate themselves together to form a corporation under the Laws of State of Florida.

ARTICLE I - NAME

The name under which this corporation will conduct its business and be known and recognized is: IG and DG Corporation.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to transacted by this corporation shall be: Repairs and Instalations of Fences and any related activity and any and all activities permitted under the Laws of the State of Florida and the United States of America.

ARTICLE III - CAPITAL STOCK
