The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **Clyde's Heating & Air, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in **Leon County**, the principal place of business and street address of this corporation shall be: **21501 Blountstown Hwy - Tallahassee, Florida 32310**

ARTICLE III - PURPOSE
