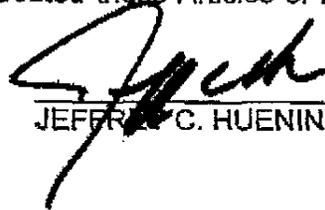
ARTICLE VI - Indemnification

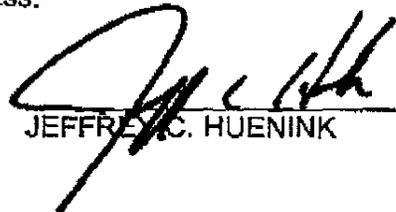
