ARTICLES OF INCORPORATION

OF

A GREEN & YELLOW BASKET, INC.

The undersigned, for the purpose of forming a corporation under Chapter 607 of the Florida Statutes, hereby agree to the following:

ARTICLE I

CORPORATE NAME

The name of this Corporation is A GREEN & YELLOW BASKET, INC. (hereinafter referred to as the "Corporation").

ARTICLE II

INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III

COMMENCEMENT DATE AND DURATION
