ARTICLES OF INCORPORATION OF ADAM B. SWICKLE, P.A.

The undersigned incorporator, for the purpose of forming a professional corporation with the Florida Professional Service Corporation Act, hereby adopts the following Articles of incorporation for such professional corporation.

ARTICLE I

The name of the professional corporation shall be Adam B. Swickle, P.A.

ARTICLE II

The professional corporation shall have the power to engage in the general practice of law and to render such services as may be ancillary to the foregoing in accordance with the Rules Regulating the Florida Bar and the Rules of Professional Conduct contained therein. The professional corporation may purchase and own real and personal property necessary or appropriate for rendering its professional services and may invest its funds in real estate, mortgages, stocks, bonds, and any other type of investments, all in accordance with the provisions of F.S.A. 621.

ARTICLE III

The aggregate number of shares that the professional corporation shall have authority to issue and to have outstanding at any on time is one thousand (1,000) shares with a per value of (5.01). All such shares shall be of a single class and designated as common.

ARTICLE IV

Each holder of common shares shall have one vote for each such share held of record on all metters submitted for shareholder approval. Except as otherwise specifically required by law, or except as specifically provided in these articles of incorporation, all other matters requiring shareholder approval shall require an affirmative vote of a majority of the shares voting thereon.

ARTICLE V

The professional corporation elects to have preemptive rights.

ARTICLE VI

The professional corporation shall indemnify to the fullest extent permitted by the Florida Business Corporation Act any person who has been made, or is threatened to be made, a party to an action, suit, or proceeding, whether civil, criminal, administrative, investigative, or otherwise (including an action, suit or proceeding by or in the right of the professional corporation), by reason of the fact that the person is or was a director or officer of the professional corporation, or a fiduciary within the meaning of the Employee Retirement Income Security Act of 1974 with respect to an employee benefit plan of the professional corporation, or serves or served at the request of the professional corporation as a director, or as an officer, or as a fiduciary of an employee benefit plan, of another corporation, partnership, joint venture, trust or other enterprise. In addition, the professional corporation shall pay for or reimburse any expanses incorred by such persons who are parties to such proceedings, in advance of the final disposition of such proceedings, to the full extent permitted by the Florida Business Corporation Act.

ARTICLE VII

The Florida Control-Share Acquisition sections of the Florida Business Corporation Act (\$\xi\$ 607.0901 through 607.0903) shall not be applicable to this professional corporation.

ARTICLE VIII

The bylaws of the professional corporation may be amended by majority vote of either the directors or the shareholders.

ARTICLE IX

The number of directors of the professional corporation shall be set by the bylaws of the professional corporation.
