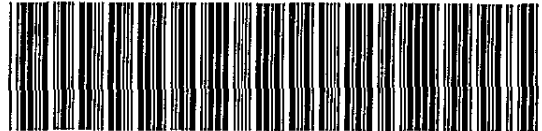



The power to adopt, alter and amend or repeal the By-Laws shall be vested in the Board of Directors.


