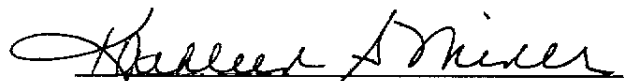
BEFORE ME, the undersigned Notary Public in and for the County and State aforesaid, personally appeared ADAM WROBLEWSKI, who deposes and states:

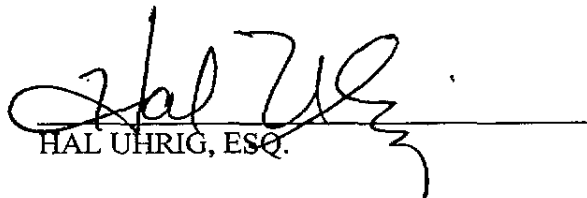
