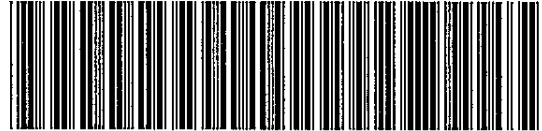

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is ~~Drywall Services of Florida, Inc.~~ DRYWALL LABOR SERVICES, INC.

ARTICLE II

Terms of Existence

The corporation shall have perpetual existence, commencing on June 1, 2003, or the date the Articles of Incorporation are received by the Secretary of State for the State of Florida, whichever is later.

The preemptive right of each individual shareholder shall entitle such shareholder to purchase a percentage of the stock to be issued by the corporation such that his or her proportionate ownership interest in the corporation will remain the same.


