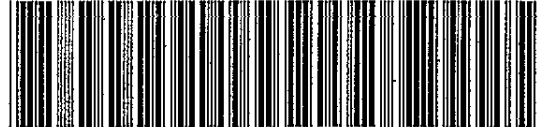

ARTICLES OF INCORPORATION

OF

WATERFRONT HOME BUILDERS OF LEE COUNTY, INC.

ARTICLE I

NAME AND ADDRESS

The name of this corporation is WATERFRONT HOME BUILDERS OF LEE COUNTY, INC. and its principal address is 2033 Trade Center Way, Naples, Florida 34109.

ARTICLE II

DURATION

This corporation shall exist perpetually commencing on the date of execution of these Articles of Incorporation.

ARTICLE III

PURPOSE

This corporation is organized to engage in the business of buying and selling real estate, real estate development, building and selling homes and for all other purposes allowed a Florida corporation.

ARTICLE IV

CAPITAL STOCK

The corporation is authorized to issue 7,500 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 2033 Trade Center Way, Naples, Florida 34109 and the name of the initial registered agent of this corporation at that address is STANLEY RICHARDS.

ARTICLE VI

INITIAL BOARD OF DIRECTORS

This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the By-Laws but shall never be less than one. The names and addresses of the initial directors of this corporation are: Monte Enoch, 3950 Estero Boulevard, Fort Myers Beach, Florida 33931 and Stanley Richards, 2033 Trade Center Way, Naples, Florida 34109.

ARTICLE VII

INCORPORATORS

The names and addresses of the persons signing these Articles are: Monte Enoch, 3950 Estero Boulevard, Fort Myers Beach, Florida 33931 and Stanley Richards, 2033 Trade Center Way, Naples, Florida 34109.

ARTICLE VIII

BY-LAWS

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE IX

SHAREHOLDER QUORUM

Fifty-one percent of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of the shareholders.

ARTICLE X

APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER

The approval of the shareholders of this corporation to any plan of merger is required, even if that approval is not required by law.

ARTICLE XI

NO REMOVAL OF DIRECTORS

The shareholders of this corporation are not entitled to remove any director from office during his term without cause.

ARTICLE XII

INDEMNIFICATION



The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law against all expenses, costs, damages and attorneys' fees reasonably incurred for any action or inaction in connection with the corporation except for a criminal act, gross negligence or willful misconduct. An officer or director shall not be liable to the corporation for any loss or damage sustained by it for any action taken or omitted by him if he in good faith exercised the care of a prudent man, in good faith acted or failed to act based upon advice of counsel for the corporation or on the books and records of the corporation, or followed what he believed to be sound accounting and business practice.

ARTICLE XIII

AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment to them by a two-thirds vote of the shareholders.



