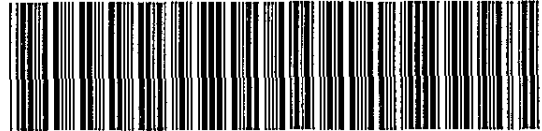

ARTICLES OF INCORPORATION

OF

The undersigned, who is duly licensed to practice the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, adopt the following Articles of Incorporation:

ARTICLE I
