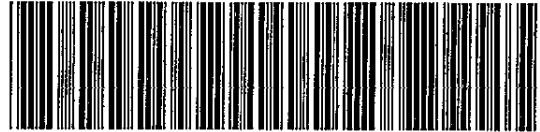

ARTICLE I
