The undersigned incorporator to these Articles of Incorporation, hereby
forms a professional service corporation for the practice of physical therapy
Pursuant to the laws of state of Florida, chapters 621 and 486, Florida Statutes.

ARTICLE I

NAME

ARTICLE II

NATURE OF BUSINESS

This corporation is organized for sole and specific
purpose of rendering professional and licensed physical
therapy services, as defined by chapter 486, FLORIDA
STATUTES.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this
corporation is authorized to have outstanding at any one time

is seven thousand five hundred (7,500) shares of common stock having a par value of one dollar (\$1.00) per share.

Shares may be issued only for a consideration having, in the judgment of the Board of Directors, at least equivalent to the full par value of the stock to be issued. All shares issued shall be fully paid and nonassessable. Shares of stock may only be issued to individuals who are licensed to practice law within the state of Florida.

ARTICLE IV

TERM OF EXISTENCE

This corporation is to exist perpetually, commencing on the date of execution and acknowledgement of these articles of incorporation, which is the 1st day of May 2003.

ARTICLE V

REGISTERED AGENT AND INITIAL OFFICE

The Registered agent and the street address of the initial Registered Office of the Corporation shall be:

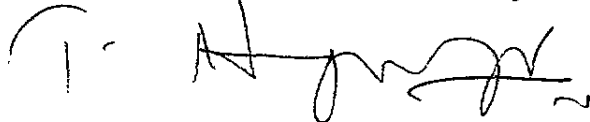
ARTICLE XI

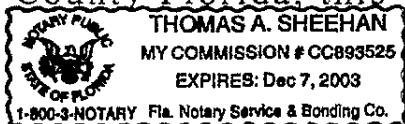

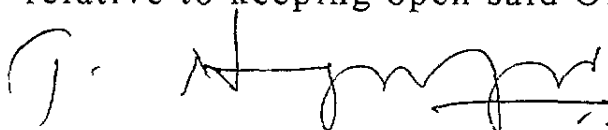
