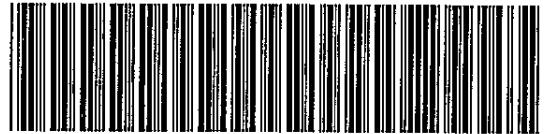

ARTICLES OF AMENDMENT OF THE

3. The last sentence of Article III, CAPITAL STOCK shall be amended as follows:

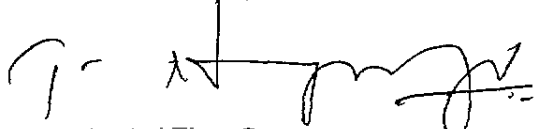
Shares of stock may only be issued to individuals who are licensed to practice physical therapy within the state of Florida.
