ARTICLE I - NAME AND ADDRESS

The name of this corporation is Carney-Neuhaus Construction Corp. The street address for the corporation is 3050 Biscayne Boulevard, Suite 200, Miami, Florida 33137.

ARTICLE II CORPORATE EXISTENCE


