ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is ARCHIVOS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 7151 Pioneer Road, W. Palm Beach, Florida, 33413.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) per value common stock which shall be designated as "Common Shares".
