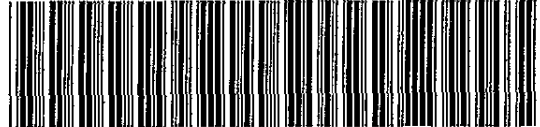


ARTICLE VI. PURPOSE, POWERS AND TERM OF EXISTENCE


DESIGNATION AND ACCEPTANCE OF REGISTERED AGENT
