ARTICLES OF INCORPORATION

The undersigned being a natural person, for the purpose of becoming a corporation under the laws of the State of Florida, and under the provisions of the Florida Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is THE KNOTICAL BOUTIQUE COMPANY ARTICLE II

The general nature of the business to be conducted and carried on by this Corporation is:

- A. To engage in all phases and aspects of the retail garment and clothing industry.
- B. To engage in all phases of work regarding the acquisition and disposition of real and personal property, both tangible and incangible.
- To engage in every aspect and phase of each and every lawful business or operation permitted by the laws of the State of Florida.

The foregoing shall not restrict any other lawful business of the Corporation.

The Corporation shall, in addition, have the power to carry on any other lawful business whatsoever in connection with the foregoing.

ARTICLES III

- The stockholders are authorized to issue and have outstanding at any time 1000 shares of common stock with no par value.
- B. The Stockholders are authorized to enter into an agreement regarding the limitations and requirements of voting, which agreement shall be binding upon all persons.

ARTICLE IV

The amount of capital with which this Corporation may begin business shall not be less than Five Hundred and No/100 Dollars (\$500.00).

ARTICLE V

The Corporation shall commence business on the day of incorporation and ice continued existence shall be perpetual.

- To create mortgages and liens upon the real and з. personal property of the Corporation.
- To create out of any funds of the Corporation available for dividends, a reserve or reserves for any purpose.
- After approval of the holders of all of the stock issued and outstanding, to sell, lease or exchange all of the property and assets of the Corporation, upon such terms and conditions, as the Board of Directors shall deem expedient and for the best interests of the Corporation.
- 6. To enter into any contract or transaction between the Corporation and any other firm or corporation the existence of which shall not be affected or invalidated because any one of the Directors or Officers of this Corporation is interested in, or is a member, stockholder, director or officer of such other firm or corporation or has ownership or equitable interest in the real or personal property involved in the transaction.
