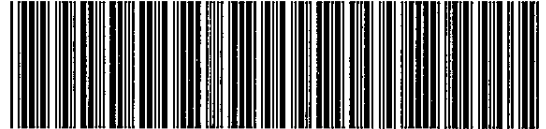



The issued shares of this corporation will be exchanged as necessary to reflect the amended corporate name.


THIRD: The date of the amendment's adoption is September 1, 2003.
