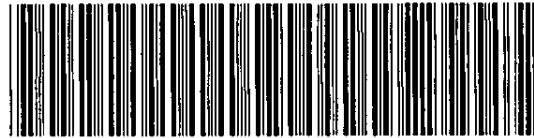

The dissolution was approved by the shareholders. The number of votes cast for dissolution was sufficient for approval.

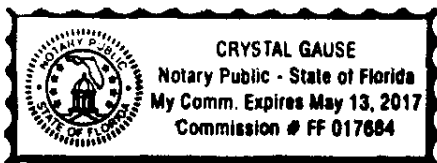
