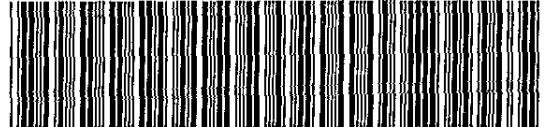



The name of this corporation is: Freedom Zone Networks, Inc.

ARTICLE VI


