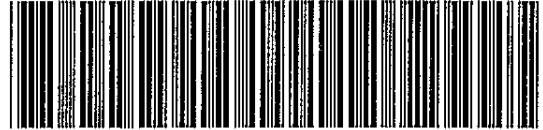

The name of the corporation ("Corporation") is VICTORIA'S, INC. *of South Florida*

ARTICLE II
