ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is What's New Pussycat, Inc. at 206 East Eau Gallie Blvd., Indian Harbor Beach, FL 32937 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE
