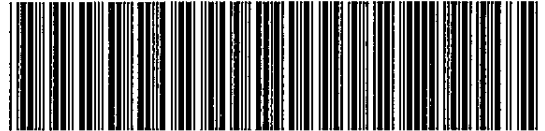




3. In all other respects, the original Articles of Incorporation are readopted, realleged and restated as if fully set forth herein.
