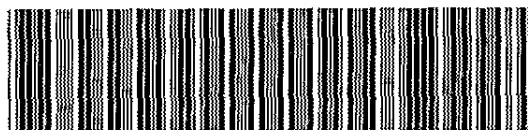

ARTICLE I – NAME

The name of this incorporation is **VIRGILIO SIERRA CABINET MAKER, INC.**
