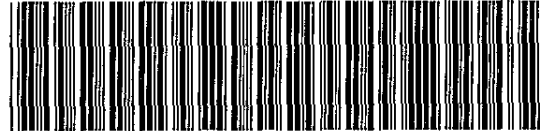

**ARTICLES OF INCORPORATION
OF
BASILICO INVESTMENTS, INC.**

The undersigned incorporator, Robert F. Basilico, hereby forms Basilico Investments, Inc., a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE V. TERM OF EXISTENCE


This corporation is to exist perpetually.
