

The general nature of the business to be transacted by this corporation shall be as follows:

- A. Real estate investments.
- B. To purchase, lease and hold real and personal property and any and every interest therein and chooses in action secured thereby; to improve manage, operate, sall, mortgage, lease and otherwise dispose of any property; to loan money to take mortgages and assignments of mortgages upon such property and to transact all or any other business which may be necessary, incidental or proper to the exercise of any or all of the aforesaid purposes of the corporation.


