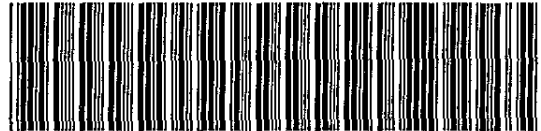

ARTICLE I - NAME

The name of this corporation shall be:

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be:

ARTICLE III - DURATION


ARTICLE X - INDEMNIFICATION


