ARTICLES OF INCORPORATION OF D & W CONCRETE COATINGS, INC.

CECRETAL PROPERTY.

Article I - Name

The name of this corporation is D & W CONCRETE COATINGS, INC. The mailing address/principal office of the corporation is: 198 Palmetto Pines Drive, Ormond Beach, FL 32174.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purposes
