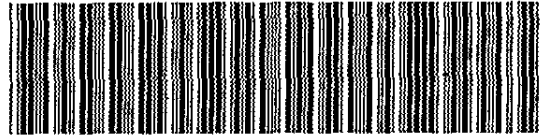

ARTICLES OF INCORPORATION
OF
PERSONAL POSTAGE CORPORATION

ARTICLE I

The name of the corporation is PERSONAL POSTAGE CORPORATION.

ARTICLE II

The corporation shall have a perpetual existence.

ARTICLE III

The general nature of the business and the objects and purposes proposed is the buying and selling of postage stamps from issuers and secondary sources and/or acting as agent for issuers and secondary sources in connection to the sale of postage stamps and for transaction of any and all lawful business for which corporations may be incorporated pursuant to Chapter 607, Florida Statutes, known as the Florida Business Corporation Act.

ARTICLE IV

The total number of shares of all classes of stock which the corporation is authorized to issue is Five Thousand (5,000) shares of voting Common Stock with One and 00/100 Dollar (\$1.00) par value.

The amount of capital which this corporation has authorized and which has been paid in as of this date is Five Thousand and 00/100 Dollars (\$5,000.00).

ARTICLE V

The street address of the initial principal office of the corporation is 625 Fifth Key Drive, Fort Lauderdale, Florida 33304. The principal office of the corporation may be changed to any other city of the State of Florida designated by the Board of Directors. The

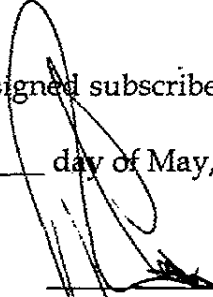
ARTICLE X

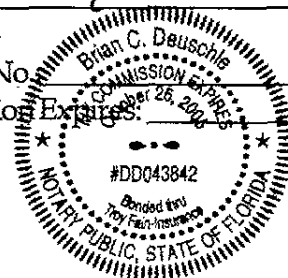
