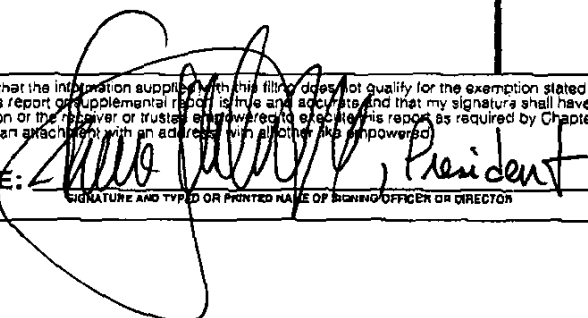

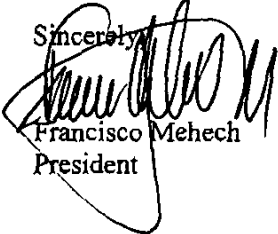
Dear Officer:
