ARTICLES OF INCORPORATION  
Of  
Eurotech of Central Florida Inc.

The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit pursuant to the Florida General Corporation Act, as particularly set forth in Chapters 607 of the Florida Statutes.

ARTICLE I – NAME

The name of the corporation is: Eurotech of Central Florida Inc.

ARTICLE II – NATURE OF BUSINESS

This corporation is organized for the purpose of general business, and the transaction of any and all lawful business including but not limited to:

- a. The repair and installation of woodworking machinery,
- b. Sale of parts and materials and services related to the above,
- c. Any other legally permitted business enterprise,
- d. Acquiring, purchasing, leasing or otherwise using, selling, exchanging or otherwise disposing of or improving property including, but not limited to personal property and real estate,
- e. Contracting with employees, independent contractors, and financial institutions in furtherance of the business,
- f. Pledging of corporate assets for the acquisition of loans,
- g. Purchasing of assets of any type whatsoever from any person or entity.

ARTICLE III – TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE IV – ADDRESS

The address of the principal office of this corporation is: 2905 Hoffner Ave. Orlando, Florida 32812. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.

ARTICLE V – DIRECTORS

The business and the affairs of this corporation shall be managed by a Board of Directors which shall be elected by the shareholders and serve as provided in the By-Laws. The number of the members of the Board of Directors may either be increased or decreased from time to time by the By Laws, but shall never be less than one. The corporation shall have one director initially.
