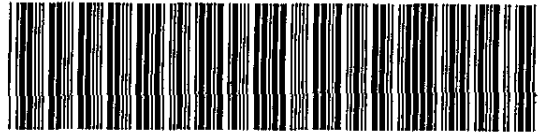



AMENDMENT**


