Conflict of Interest



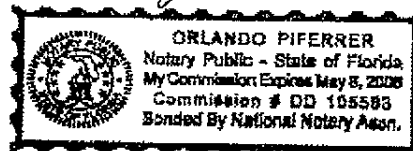
