ARTICLES OF INCORPORATION MJL SELECT, INC.

The undersigned, acting as incorporator of a corporation to be formed under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation for such corporation, to be filed with the Secretary of State of the State of Florida:

ARTICLE 1

The name of the corporation shall be MJL SELECT, INC. The principal place of business of this corporation shall be 3232 Emathia Street, Coconut Grove, Florida 33133.

ARTICLE II

The Corporation shall have perpetual existence commencing at the filing of the Articles of incorporation with the Department of State.

ARTICLE III

The general nature of the business to be carried out by the Corporation is as follows:

- To carry on any and all lawful purposes not specifically prohibited or limited by Chapter 1) 607, Florida Statutes.
- To do any and all things necessary, suitable, useful, proper or admissible for the accomplishment of any of the purposes, or for the attainment of any of the objects, or for the exercise of any of the powers herein set forth, whether specified or not, either alone or in connection with other firms, corporations or individuals, either in this State or throughout the United States and elsewhere, and to do any other act or acts, thing or things, incidental or pertinent to or connected with the business herein before described, or any part or parts thereof, if consistent with the laws of the United States, this state or any other state.

A Board of Directors consisting of not less than One (1) nor more than seven (7) members shall be elected at the first annual meeting of stockholders and at each annual meeting thereafter. Unless otherwise prescribed by law, the entire voting power to elect Directors and for all other purposes shall be vested exclusively in the holders of the outstanding shares of common stock with voting rights of the corporation.

ARTICLES VIII

The Corporation shall have all the powers enumerated for a corporation under the laws of the State of Florida.

ARTICLES IX

The Corporation shall indemnify and hold harmlessly any and all of its Directors and Officers to the full extent permitted by law.
