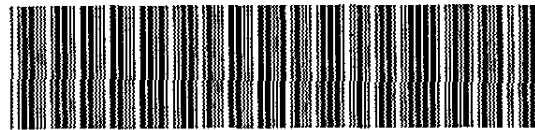



The initial street address in the State of the principal office of the corporation shall be as follows:






