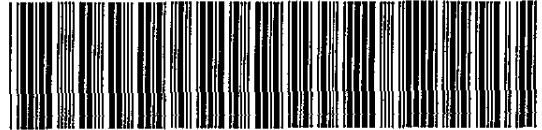

ARTICLES OF INCORPORATION OF

H.A.R.T. INVESTORS COMPANY

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is H.A.R.T. INVESTORS COMPANY.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and the mailing address of the corporation is:

ARTICLE III - PURPOSE

The corporation's business shall include the acquisition of, renovation of, management and sale of real property and all other business which is legal in the state of Florida.

ARTICLE IV - SHARES


