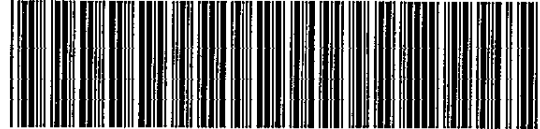

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of the Corporation is:

Buster, Corbin & Craig, Inc.

ARTICLE II - TERM OF EXISTENCE

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which the corporate existence shall begin is the date on which these Articles of Incorporation are filed with the Florida Department of State.

ARTICLE III - NATURE OF BUSINESS

The purpose or purposes for which this corporation is being organized are:

To engage in any activity or business permitted under the laws of the United States of American and of the State of Florida.

To generally have and exercise all powers, rights and privileges necessary and incidental to carrying out properly the objects herein mentioned.

To carry on any other lawful business and to do any and everything necessary, suitable, convenient or proper for the accomplishment of any of the purposes or the attainment of any or all of the objects hereinbefore enumerated or incidental to the purposes and powers herein named or for the enhancement of the value of the property of the Corporation or which at any time appear conducive thereto or expedient.

ARTICLE IV – CAPITAL STOCK

The aggregate number of shares that the Corporation shall have the authority to issue is one hundred (100) shares of capital stock with a par value per share of One Dollar (\$1.00). The shares of the Corporation are not to be divided into classes, and shall have unlimited voting rights.

ARTICLE V – INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT


