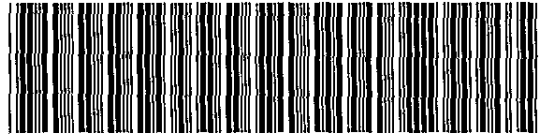

This corporation is organized for the purpose of rendering specific professional service as chiropractors.
