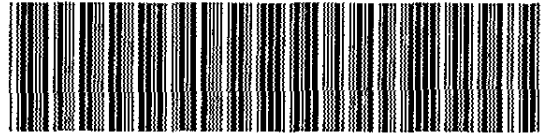

ARTICLE I - NAME

The name of this Corporation is American Business Resource Technologies, Inc.


