THE UNDERSIGNED, acting as the sole incorporator of **Florida Hedge Funds, Inc.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation of **Florida Hedge Funds, Inc.** for such corporation:

ARTICLE I

Name and Address

The name of the corporation shall be **Florida Hedge Funds, Inc.**, and its principal corporate address shall be initially located at 2710 Rew Circle, Suite 100, Ocoee, Florida 34761..

ARTICLE II

Duration

This corporation shall have perpetual existence unless sooner dissolved according to law, and shall commence its corporate existence upon the filing of these Articles.

ARTICLE III

General Purposes

This corporation is organized for the purpose of transacting, conducting, carrying on, operating, and engaging in any activity or business permitted under the laws of the State of Florida, and the United States.




