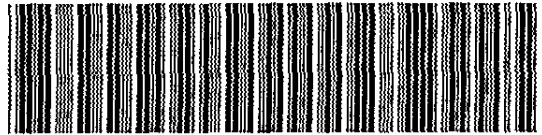

The name of the corporation is J & M ISSA CORP.

ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.

ARTICLE TEN


The powers of the incorporator cease upon filing of the Articles of Incorporation.
