ARTICLES OF INCORPORATION

OF

LINDA LOU'S HEALTH FOOD STORE, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE:

The name of the Corporation is LINDA LOU'S HEALTH FOOD STORE, INC.
