

ARTICLES OF INCORPORATION OF BOCA SKEWERS, INC.

ARTICLE I NAME

The name of this Corporation is Boca Skewers, Inc.

ARTICLE II DURATION

This Corporation shall have perpetual existence. The effective date of this Corporation shall be the date of filing of these Articles.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which profit corporations may be incorporated under the Florida General Corporation Act. No other purpose limits the general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. To operate a restaurant.

ARTICLE IV SHARES

The aggregate number of shares which the Corporation is authorized to issue is <u>one</u> hundred (100) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.
