

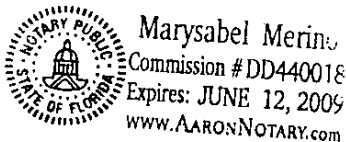
1. Ana M. Chacon is the President of THE DANCESPORT GROUP, INC., a Florida corporation, (hereinafter "Corporation").
